**DECLARATION OF CLASS COUNSEL IN SUPPORT OF
PLAINTIFFS' UNOPPOSED MOTION FOR SERVICE AWARDS TO CLASS

The undersigned hereby declare as follows:

1. The Parties have been litigating this matter for nearly a decade.
2. Over that time, the Parties engaged in extensive discovery, involving thousands of pages of documents; briefed various motions involving removal, remand, dismissal, appeal, and stay; and participated in extensive arms-length settlement negotiations with the assistance of a mediator.
3. The table below sets forth the total fees/lodestar and expenses incurred by each of our respective law firms from the inception of this case through March 31, 2026.¹

¹ At inception, both Mary E. Lentz and Micah M. Siegal were employed by the law firm Gottschlich & Portune LLP, which ultimately became Foos & Lentz, LLP in 2021. Mr. Siegal departed Gottschlich & Portune at the end of 2015, but remained counsel of record in the case and ultimately created Gibson & Siegal Co., LPA in 2024. The lodestar listed in the table for Foos & Lentz is based on a total of approximately 425 hours at an average hourly billing rate of \$400 and includes Mr. Siegal's time prior to his departure.
